**E911 CONSOLIDATION PRESENTATION**

Director Brian Hitchcock and Attorney Nicole Bennett presented the December 6, 2013 Interlocal E911 Consolidation Agreement and the changes to this agreement from a previously submitted draft. Nicole Bennett stated that the December 6, 2013 draft is the final draft and has been signed by all municipalities except 4, including the Town of Cedar Lake. Randy Niemeyer stated his concern about the lack of representation on the Consolidation Board that will represent the public's best interest, such as a Council Member. Nicole Bennett stated that at this time there is no representation such as a Council member on this Board at this time, but this is a legislative matter than can be changed in the next year. Nicole Bennett asked the Town of Cedar Lake for a decision on this agreement as this project will continue to move forward. Cedar Lake Fire Chief, Todd Wilkening stated his concern about the lack of representation from Fire Departments on the board as well as some technology radio compliance concerns. Chief of Police, Jerry Smith, stated his overall support for E911 Consolidation with some concerns about the services that may be lost in the Consolidation along with the cost of technology upgrades.
