(see attached exhibits A and B) The repayment terms of the lease are set to not to exceed \$850,000.00 per year for a term no longer than fifteen years (15). These are conservative estimates.

David Austgen: There will be an amortization once financing is completed for the amounts that will be paid. See attached exhibits for descriptions on the streets that are to be improved within this project. (group discussion)

Davis Austgen: Specimen lease agreement which will be completed once we know the rate. The amortization schedule will be attached once complete.

Ian Nicolini: Town Council will approve this March 1, 2011 and the RDA will have a meeting March 24, 2011 to complete this process. Surveying for the project has begun already. The estimated time of completion is early to mid May. These are not definite dates. The improvements are to be completed this year due to the bond time constraints.
