Monthly Reports:

Ian Nicolini: The parcel by parcel TIF analysis has been done. The next step is that London Witte Group will acquire the most up to date list that the county has in terms of their totals for the district. A comparison will be done to see where we are at then turn it over to London Witte Group for some recommendations and a full blown analysis; a recommendation will be presented at the next meeting.

Ian Nicolini: The Lighthouse is just finishing up their fifth expansion, Saint Anthony's and Luke Oil have their sight plans approved, but the final engineering plans are on hold. The old Schreiber Oil site was sold to Schillings after it was decontaminated. The 133rd second phase is still going through the process; we are waiting on the environmental documents. We are on schedule as far as progress. The Shades and Cedar Point Park project are a little behind schedule. The bids came in lower so we were able to add additional work to the existing plans. Elmwood Funeral Home is nearing completion so it will be on the next years TIF.

Old Business: TIF Capture:

Ian Nicolini: After going through the parcels it looks like we have more increment than we had in 2009 pay 2010, but we need to review 2010 pay 2011. There is a considerable amount of residential property that will need to be removed from the district. Once we see 2011 we will know what measures we will need to take, as far as if we need to prune our decrement.

Strack & Van Til: Ian Nicolini: They have preliminarily scheduled demolition for the end of the year. In the spring we will have public hearings about the economic development agreement. At that point bonds will be bought and sold then construction will take place.
