Presentation: Ian Nicolini: Two weeks ago a joint meeting with the Plan Commission, Redevelopment Commission and the Town Council to establish the sub allocation area, the TIF district within the larger TIF district for the lot of the SVT, LLC., Strack & Van Til, owned lot. Outlined within the bond ordinance in which the Town council will consider tomorrow night. The various elements of the financing include a term of eighteen and a half years and a total amount of not to exceed \$800,000.00 for the issuance and a 5% interest. Thos e bond will be issued based on the property tax increment generated by the construction of the new Strack & Van Til 45,000 to 50,000 square foot store. This will employ approximately ninety-six people with the total payroll of 1.65 million dollars. So the purpose of tonight's meeting is to consider the confirming resolution which lays out a lot of the terms reviewed in the above. This is also to pledge that TIF revenue into that project. The bonds will be purchased by SVT, LLC.

## **Report of the Economic Development Commission:**

Ian Nicolini: This is the general terms of agreement for the Town of Cedar Lake Economic Development Commission concerning the proposed financing of economic development facilities for SVT, LLC...The Town of Cedar Lake Economic Development Commission proposes to recommend to the Town Council of the Town of Cedar Lake that is loan the proceeds of certain economic development revenue bonds to SVT, LLC, or an affiliate thereof for the financing of certain economic development facilities in the Town. This consists of the acquisition, construction and equipping of a new approximately 45,000 to 50,000 square foot supermarket. The Commission estimates that no public works or services, including public ways, schools, water, sewer, street lights and fire protection, will be made necessary or desirable by the Project, because any such works or services already exist or will be provided by the Applicant or other parties. The Commission estimates that the total costs of financing the project will be approximately \$10,800,000.00. The Commission finds that the Project will not have a material adverse competitive effect on similar facilities already constructed or operating in the Town.
