Monthly Reports:

Second Phase 133rd: Ian Nicolini: Received word back from INDOT and they are not going to cost share on any of the water main extensions of the second phase of 133rd which ads approximately \$650,000.00 to the project. This is separate from our local share. We are going to re-visit the project budget. We may be well advised to increase the size of the bond for the second phase and pay for the water main improvements within the TIF district. We should have more than enough coverage.

Way-Finding: The Council should have two (2) appointments to the committee by Tuesday the 18th, which leaves the school and the RDC appointments. Becky Davis offered to sit on the Committee to represent the RDC. The commission will accept the application from Allison Vis to sit on the Committee for the RDC.

Old Business:

Patrick Conlon: Draft for the RFQ (request for qualifications) for the design of East 133rd to be sent out. The council would like to act quickly on East 133rd. We have decided to have the companies reply by January 4th 2012, so we could select a designer.

Ian Nicolini: This helps us in trying to size the bonds having a design firm that can give us an engineer's assement of probable cost. This makes sense for us to have something more concrete. Taking the three (3) firms that currently have road construction experience within Cedar Lake. The firms that will be solicited are: CBBEL, American Structure Point and NIESS Engineering. All three of these have a level of experience within Cedar Lake. (discussion regarding intersection of 133rd & Morse intersection thermoplastic)
