B. Review Expenses/Income

Clerk-Treasurer Gross discussed that not much has changed. A reimbursement arrived from INDOT for \$105,000 for a series of invoices paid to Christopher B. Burke Engineering, for the 80% reimbursable construction observation inspection. President Vis asked if she expected any more. She estimated about \$41,000 to be reimbursed. She stated the next draw should arrive the second to last week in December.

III. Update from Rex Sherrard on TIF Study

Mr. Sherrard shared scaled drawings showing parcel boundaries and TIF boundaries. Discussion followed about setting up a meeting to turn over discovery to Town employees to keep a handle on what is going on with these. He also discussed being ready to go to the Lake County Auditor's office to get some items corrected.

IV. Monthly Reports

A. 133rd Avenue Phase II – Update

Town Administrator Murr stated box culverts are being prepared. Curb work will be done next week. Paving may begin the following week, weather pending. Surface coat, sidewalks, and drive aprons will not go in until the spring. Right of Entry agreement and discussion regarding the storm retention pond with the school is moving forward.

B. East 133rd Avenue – Update

Waiting on the paperwork to close out the project.

C. Cline/Lake Shore Drive Project

Parcel number 4 is pending. Parcel number 5 is being discussed. Six of the parcels have been secured out of fourteen. One is moving towards condemnation.

D. Broadway Project

This project is done. The Town owns the necessary property to maintain the area.

E. Pending/Future Developments

Town has closed on the last parcel for Bartlett/Wahlberg Park. NIPSCO needs to retire the lines and the Fire department will be doing some training and then the structure will come down. Discussion continued on design ideas and upcoming meetings or community forums for input on the design.

V. Old Business

A. Status – 133rd East – IDEM/UST Contamination

Status conference to occur in February.

B. Park Improvement Project

C. Sign Order

Town Administrator Murr discussed that Mixdesign is to deliver the sign on November 18th.
