IV. Monthly Reports

- **A.** 133rd Avenue Phase II Paving is scheduled for Wednesday. Striping will occur shortly thereafter. Concrete punch list items started last week.
- **B.** Cline/Lake Shore Drive Project Of the 14 Right of Way Parcels, 7 have been acquired, 4 are in the process of eminent domain, 2 are being discussed with property owners, and 1 is owned by the Town. Town Administrator Murr met with NIRPC last week and it was offered to move the project up to Fiscal Year 2018. A brief discussion occurred on the possibility. President Vis asked how the relationship was with the engineer from American Structurepoint on the project. Town Administrator Murr answered it was good.

- **B.** Park Improvement Project The building is down and the ground has been graded and seeded. Looking to work with an engineer and landscape architect to develop a plan.
- **C.** Façade Grant Program Will review next month due to financial obligations. A brief discussion occurred on the big box stores and possibility of diminished TIF funds.
- **D. New Intersection 133rd/Hanover** No response from Tom Taylor, Superintendent of Hanover Community School Corporation. Town Administrator Murr added that this project has not been designed yet. It's just a concept idea, no design engineering has occurred.
- **E. Resolutions** Town Attorney Austgen discussed two resolutions for the annual TIF increment capture notices and authorization. The first is for the consolidated 133rd Avenue economic development area and the second for the Strack and Van Til area. This needs to be adopted so that 100% of the TIF increment can be captured.
