Additionally, they are thinking of replacing the welcome sign out front of the Town Grounds and placing it at entrances of the community, near the middle school and Lemon Lake Park. The signs would be rolled out over the next couple of months so that there wouldn't be a large impact to cash flow. There is money available to do all six signs with this years' budget. Discussion continued on placement, size, and cost of the signage. Council Member Carnahan voiced concerns over the year of incorporation on the sign. It was discussed that the correct year would be researched. Discussion continued on the total cost of signs. Cost is approximately \$14,000 for all six signs.
