

**Storm Water Board  
Work Session  
June 10, 2014  
7:00pm**

The Storm Water Board for the Town of Cedar Lake held a Work Session on June 10, 2014. The meeting was called to order at approximately 7:02 p.m. Members present were: Glenn Sechen and Norman Stick. Staff present were: James Cornett of Public Works and Shelly Myers, Recording Secretary. Councilman Robert H. Carnahan and Mark Kaiser of Christopher B. Burke Engineering were in attendance. The Pledge of Allegiance started the meeting.

- I. **Public Comment:** Chester Sparacio 13119 Lindberg Cedar Lake, Indiana 46303 and Dan Blondeel 13120 Lindberg Cedar Lake, Indiana 46303 brought photos and voiced concerns of a problem with a huge cottonwood tree causing issues under the road. Jim Cornett will call Mr. Sparacio tomorrow and go out to take a look.

- III. **Business Items**
  - A. **Mr. Daryl Dust, 13225 Colfax:** Jim Cornett has come up with a fix, so this can be removed from the agenda.
