



**Storm Water Board
Public Meeting
May 26, 2015 7:00pm**

The Storm Water Board for the Town of Cedar Lake held a Public Meeting on May 26, 2015. The meeting was called to order at approximately 7:01 p.m. Members present were: Paul Steininger, William Thompson and Daniel Enright. Town Administrator Jill Murr and Council Member Robert Carnahan were in attendance. Public Comment: Bill & Elaine Edwards of 10535 W. 129th Ave. mentioned an issue he is having. Mr. Edwards has a small pond, and someone on the other side has blocked the drainage to create a pond causing Mr. Edwards pond to back up. The address of that area is 10903 W. 129th. Paul Steininger told Mr. Edwards we would add him to next month's meeting agenda, and they will go check it out in the meantime.

A. Meyer Manor -Truman Circle

Jill Murr mentioned to the board that she had a meeting with Nicole Laurenaitis and walked the area. They discussed a few options. Jill will reach out to Terri again and inquire since Terri was forwarding it to a different division (water division of DNR). Tim Kubiak mentioned that there are still concerns of the fence location and a survey is needed. Robert Carnahan mentioned he was walked the area and noticed the weeds are over grown and a lot of poison ivy. Jim Cornett told Robert Carnahan he would try to get the poison ivy sprayed. We will keep this item on the agenda.

B. 7117 W.127th Pl.

Paul Steininger asked Robert Carnahan if the meeting he planned ever took place? Robert Carnahan mentioned there are some issues with Community Grant Funds; they are trying to send letters to residents. Jill Murr mentioned that hopefully we will have more information and clarification before the next meeting. This item will be continued until next month's meeting.
