# Public Comment:

- Robert Brown, 8142 127<sup>th</sup> Ave, Cedar Lake, IN 46303, house has been flooded three times during the vast downfall. Over 40 years ago a 300ft pipe was installed on the property. It is draining from the top of the hill straight down to their house causing the flooding. Paul Steininger asked when Robert Brown believes the pipe was installed, if it was the Town of Cedar Lake or previous owner. There was not an answer for that. The board will look into this issue.
- Judy Burandt, 12714 Maple St., Cedar Lake, IN 46303, has lived in Cedar Lake for 50 years. Since the new drainage in water shoots up and starts flooding everyone on the street. The ditch keeps over flowing. The Burandt family has not dealt with a water issue till now. Judy Burandt stated that someone on Oak St. sump pump is going to her house. The board will look into the issue.
- Debra Greene, 7109 W 140<sup>th</sup> Ave, Cedar Lake, IN 46303, lives at the bottom of the hill. Debra Greene stated that asphalt is covering the sewer drain. Debra Green showed the board pictures from her cell phone of the issue. The end of the ditch keeps overflowing into her yard. The board will look into the issue.
- Ron Bailey, 14001 Fairbanks, Cedar Lake, IN 46303, this is their third time flooding. Bob Carnahan took pictures of the issue.
- Anthony Putzbach7316 W 142<sup>nd</sup> Ave and 7416 W 142<sup>nd</sup> Ave, Cedar Lake, IN 46303, 142<sup>nd</sup> Ave has an S curve. There is an underground storm water drain running east and west along his property. The ditch is getting filled by someone on that street causing flooding around that area.
- Brandlyn Chalmers, 7416 W 142<sup>nd</sup> Ave, Cedar Lake, IN 46303, has lived there for two months the S curve and drainage has caused flooding. Their garage keeps getting flooded.
- Guy Cochran, 13131 Parrish, Cedar Lake, IN 46303, they have a storm water drain. The Town was going to get an easement from him or his neighbor to fix the line. Jim Cornett remember this being discussed with previous board but does not remember where it left off at. The board will follow up with this issue.

- Philip Krizmanic, 7314 W 131<sup>st</sup> Ave and 7305 Lakeshore Dr., Cedar Lake, IN 46303, the water draining down from 7314 W 131<sup>st</sup> Ave has caused major flooding. Philip Krimanic had to get 70 sandbags. Jim Cornett said they have tried numerous of things but the force behind the water is too powerful.
- Lucy Griffin, 13704 Birch, Cedar Lake, IN 46303, she was here a year ago. The Winding Creek II subdivision got built right behind her house. The houses are built up higher than hers making the yard flood. They cannot discharge their water into your property, Daniel Enright stated. The board will look into this issue and ask building commissioner to help.

- B. 7117 W. 127<sup>th</sup> Place- Drainage Issue: Bob Carnahan had to go house-to-house Federal Government survey to meet the 51% modern lower income. They are purchase pipe and have the street department to install it. Everything East on Edison is done and everything west is getting done. Jill Murr stated that funding will not be available until October. It gives everyone time to plan appropriately.
- C. Wicker Meadows: Jill Murr stated she knew that Jim Cornett's guys were out there the overflow is working really well. The Lake County Surveyor will be present at the next Town Council meeting.

#### **New Business:**

- A. Bill & Elaine Edwards 10535 W. 129<sup>th</sup> Ave- Paul Steininger and Daniel Enright went out to investigate. What they found was the natural waterway was blocked by the neighbor. It was to create a pond. The water is getting backed into Bill & Elaine Edwards property. Daniel Enright stated that we need to send a certified letter or fine them for blocking the natural waterway. Daniel Enright is not positive on the best route to take for this. Jill Murr thinks the best way would be to send Tim Kubiak, Building Commissioner, out to talk to him first. If no compliance than a certified letter will be issued, if no response than a fine. A motion made by Daniel Enright and seconded by Paul Steininger to approve Town Administrator Jill Murr recommendation.
- B. Ron & Debbie Bailey 14001 Fairbanks- Jill Murr and Don Oliphant went over to this area and examined the area. Jill Murr will like to be able to continue having Don Oliphant looking at the drainage issue.
