- A. Muir Woods, Lots 5 & 6, 13660 Muir Ln.-deferred to April 25, 2017 Meeting-Don Oliphant stated the Plan Commission approved to do the drainage, not the subdivision.
- B. Josh Strominski, 13700 Lauerman St.- deferred to April 25, 2017 Meeting-Don Oliphant stated have a finished design, waiting for bids to do in spring pending funding. Discussion on if this plan was approved for construction and where the funds would come from.
- C. Jeff Nelson, 12839 Colfax St.-Daniel Enright, Scott Hutchinson and Tim Kubiak went out to look at the properties. Found the drain and swale are slow, but functioning. The biggest problem is the sump pump running out the back of the house. Had an estimate to go in with a 6" pipe with 2 grade level grates and lids and labor, cost is approximately \$13,000. Will have to put this off for the current time, have other more pressing concerns that need to be dealt with first. Discussion on easements ensued and placement of shed. No action will be taken at this time.
