This hearing was transcribed by a court reporter, and the transcription shall be an exhibit to the minutes of this meeting for evidence of verbatim discussion.

President Randell Niemeyer addressed the public concerning the hearing for Ordinance No. 1212A being the annexation along the US 41 South Corridor. The purpose and initiative of this annexation is that this is the only annexation. Contrary to what has been heard, there are no phases. President Niemeyer addressed the concerns regarding agricultural and unique uses of land, zoning requirements, sale or transfer of properties, municipal utilities, the 2012 comprehensive plan, and the Illiana corridor. The purpose for this meeting is the Illiana development, which started before delays were apparent.

Chronological Events:

- 1) First reading of Ordinance No. 1212 on November 18, 2014.
- 2) Public hearing scheduled on February 17, 2015. Motion made by Greg Wornhoff with second by Patsy Casassa. There was unanimous approval by the Town Council.
- Approval of Resolution No. 1128 adopting fiscal plan also took place on November 18, 2014. Motion made by Greg Parker with second by Greg Wornhoff. There was unanimous approval by the Town Council.
- 4) Notice of public hearing and accompanying map of annexation area published on December 16, 2014 in the Post-Tribune and NWI Times.
- 5) Notice of public hearing was sent by certified mail to 240 property owners in the annexation area, and 5 property owners abutting the annexation area on December 11 and 12, 2014.
- 6) There was a discovery of a scrivener's error in the legal description on January 6, 2015. The February 17, 2015 hearing was then cancelled. The error was reported to the Town Council on January 6, 2015.
- 7) The Town amended the first reading of annexation Ordinance No. 1212A reflecting the change in legal description on January 20, 2015. The public hearing was then scheduled for tonight April 7, 2015. The motion was made by Robert Carnahan with second by Patsy Casassa. There was unanimous approval by the Town Council.
- 8) There was then approval of Resolution No. 1128A adopting the amended fiscal plan on January 20, 2015. Motion by Carnahan and second by Casassa with unanimous approval by the Town Council.
- 9) Notice of public hearing with accompanying map of annexation area published on February 5, 2015 in the Post-Tribune and NWI Times.
- 10) Notice of public hearing sent by certified mail to 240 property owners in the annexation area, and 5 property owners abutting the annexation area on February 5, 2015.

All documents associated with the US 41 South Corridor annexation have been available on the Town's website and at the Town Hall for public inspection continually since then. Owners located within the annexation area have been able to request copies free of charge from the Town Hall.

Subsequent Steps:

Upon completion of the public hearing, the Town Council will have a transcript prepared for review with consultants and legal counsel. Following the statutory guidelines, the Town Council will reconvene between 31 and 60 days after this hearing to consider and/or adopt the ordinance as it was originally presented or as amended. If a final ordinance is adopted, it will be published according to statutory procedures. This hearing has procedures as well, and is being held according to applicable law.

The annexation area, US 41 South Corridor, has been clearly defined and any rumors of subsequent phases are not true. The Illiana Expressway and the opportunity to grow economically using best land practices to preserve character of the area, is the purpose.

Attorney Stephen Buschmann, of Thrasher, Buschmann & Voelkel, PC, Indianapolis, Indiana, was invited to address the Town Council. Mr. Buschmann represents the "No Cedar Lake Annex" group. Mr. Buschmann focused briefly on recent annexation cases with City of Sullivan, Town of Whitestown and Town of Fortville. In each case, the municipalities were annexing land that was

largely agricultural. The trial courts ruled in favor of the remonstrators. City of Sullivan appealed, but again the court ruled in favor of the remonstrators. The Towns of Whitestown and Fortville are in the process of appeal. The latter two municipalities spent about \$200,000 each in fees to push the annexations. The Town Councils did not think of what happens if they lose. Mr. Buschmann asked for consideration when hearing the people, particularly dealing with agricultural land. The laws are changing and the Indiana General Assembly just passed the annexation bill SB #330 out of committee by a vote of 11 to 1 today. Most annexations would stop with the petition process.
