ORDINANCE NO. 1352

AN ORDINANCE OF THE TOWN OF CEDAR LAKE, LAKE COUNTY, INDIANA, ESTABLISHING A REIMBURSEMENT FEE TO BE CHARGED AND COLLECTED FROM RESPONSIBLE INDIVIDUALS AND ENTITIES RENDERED FIRE, SAFETY AND RESCUE, AND HAZARDOUS MATERIAL AND ENVIRONMENTAL INCIDENT RESPONSE SERVICES BY THE TOWN MUNICIPAL FIRE DEPARTMENT, REPEALING ALL ORDINANCES AND TOWN CODE PROVISIONS, OR PARTS THEREOF, IN CONFLICT HEREWITH, AND ALL MATTERS RELATED THERETO.

WHEREAS, the Town of Cedar Lake, Lake County, Indiana (hereinafter, "Town"), is a unit of local government duly organized and existing as a Municipal Corporation in the State of Indiana; and

WHEREAS, the Town, as a duly organized and existing unit of local government, is governed by its legislative body, the Town Council; and

WHEREAS, the Town Council of the Town of Cedar Lake, Lake County, Indiana (hereinafter, the "Town Council"), is responsible for the conduct of the business of the Town for the benefit of its Town residents and citizens, as set forth in applicable provisions of the Indiana Code, as amended from time to time; and

WHEREAS, the Town Council, in the course of its responsibilities and obligations for provision of services to Town residents and citizens has established and maintains a Municipal Fire Department for such purposes; and

WHEREAS, the Town Council, in the course of its establishment of a Municipal Fire Department, was aware that the Town Municipal Fire Department renders fire, safety and rescue, and hazardous material and environmental incident response services to Town residents and citizens, and those for whom such services are required within the jurisdictional and service territory of the Town Municipal Fire Department; and

WHEREAS, the Town Council is aware of the service levels required to be maintained by the Town Municipal Fire Department for provision of fire, safety and rescue, and hazardous material and environmental incident response services, in addition to other related services, and specifically the budgetary cost provided annually to the Town Municipal Fire Department for same; and

WHEREAS, the Town Council has been informed and advised that in the course of establishing a Municipal Fire Department, and directing said Municipal Fire Department to provide fire, safety and rescue, and hazardous material and environmental incident response services, that insufficient funds are able to be budgeted and/or made available for the Town Municipal Fire Department for provision of such services; and

WHEREAS, the Town Council, being duly advised, has examined methods and means outside the Town General Fund budget to fund and subsidize the General Fund budget provided to the Town Municipal Fire Department for its provision of fire, safety and rescue, and hazardous material and environmental incident response services by the Town Municipal Fire Department, and has determined that additional sources of revenue are required for such services to be provided; and

WHEREAS, the Town Council has been informed and advised that the provisions of the Indiana Home Rule Statute, cited at I. C. § 36–1 –3, make applicable to all units of local government in the State of Indiana, including the Town, Home Rule Authority for fulfillment of the policy of the State set forth at I.C. § 36-1-3-2, which is to grant units, including the Town, all the powers that they need for the effective operation of government as to local affairs; and

WHEREAS, the Town Council has been duly informed that the Indiana Home Rule Statute (i.e. I.C. § 36-1-3, et seq.), is available for establishing regulations it deems appropriate for the effective operation of government in the provision of services for the residents and citizens of the Town, and now concurs that this statutory authority should be considered and utilized for such purpose and provision of services by the Town Municipal Fire Department; and

WHEREAS, the Town Council, utilizing the provisions of the Indiana Home Rule Act at I.C. § 36-1-3, et seq., as amended, is applicable and permits the Town Council to establish by enabling Ordinance a Reimbursement Fee to be charged and collected from responsible individuals and entities rendered fire, safety and rescue, and hazardous material and environmental incident response by the Town Municipal Fire Department in order for the Town to operate and conduct the business of the Town Municipal Fire Department, including the provision of the aforementioned services; and

WHEREAS, the Town Council being further duly advised, now concurs and agrees that it is in the best interests of the residents and citizens of the Town that there be established a Reimbursement Fee to be charged and collected from responsible individuals and entities rendered fire, safety and rescue, and hazardous material and environmental incident response services by the Town Municipal Fire Department, consistent with applicable law, and as the same is in the best interests of the Town.

NOW, THEREFORE, BE IT ORDAINED BY THE TOWN COUNCIL OF THE TOWN OF CEDAR LAKE, LAKE COUNTY, INDIANA, AS FOLLOWS:

SECTION ONE: Legal Authority.

The Town Council hereby declares that its establishment hereinafter of a reimbursement fee to be collected from responsible individuals and entities rendered fie, safety and rescue, and hazardous material and environmental incident response services by the Town Municipal Fire Department, is based upon the Indiana Home Rule Statute cited at I.C. § 36-1-3, et seq., and specifically, the provisions of said Home Rule Statute granting the Town, as a unit of local government in the State of Indiana, all the power it needs for the effective operation of government in the Town as to Town responsibilities to its citizens and residents.

SECTION TWO: **Establishment**.

The Town Council hereby establishes a Reimbursement Fee to be charged and collected from responsible individuals and entities rendered fire, safety and rescue, and hazardous material and environmental incident response services by the Town Municipal Fire Department, in conformance with the provisions of I.C. § 36-1-3 (5) which permits the Town, as a unit of local government, to impose a fee reasonably related to the administrative costs of exercising the power and providing the services so described. The fee established will be for reimbursement of costs incurred by the Town Municipal Fire Department to be charged and collected from responsible individuals and entities rendered fire, safety and rescue, and hazardous material and environmental incident response services by the aforesaid Town Municipal Fire Department hereafter. The reimbursement fee established hereby and authorized to be charged and collected from responsible individuals and entities rendered fire, safety and rescue, and hazardous material and environmental incident response services, shall be based upon the services requested and/or required in the event of any fire, safety and rescue, and hazardous material and

environment incident services response made by the Town Municipal Fire Department. In all instances of such services being provided, reimbursement for same shall be made under the authority of this enabling Ordinance.

SECTION THREE: The Town Council hereby directs the Town Administrative Offices and Municipal Fire Department Administrators to develop and create a fee schedule related to the fire, safety and rescue, and hazardous material and environmental incident response services to be provided by the Town Municipal Fire Department, which schedule of reimbursement fees establishes a schedule of user fee under the provision of I.C. § 36-1-3-8 (5) and (6), being reasonably related to the specified services rendered.

SECTION FOUR: That the schedule of reimbursement fees for provision of fire, safety and rescue, and hazardous material and environmental incident response services by the Town Municipal Fire Department shall be a specific exhibit to this Ordinance, to be labeled as Exhibit "A", and is to be appended hereto as such Exhibit "A". Under current applicable law as forth in the current Indiana Home Rule statute, as amended from time to time, and as cited at I.C. § 36-1-3, et seq., the Exhibit "A" list of rates and charges for reimbursement of fire, safety and rescue, and hazardous material and environmental incident response services for which reimbursement fees are to be charged and collected from responsible individuals and entities provided such services shall be attached hereto, included herein and incorporated. Further, the schedule shall be reviewed annually for update and current application of reasonable and just reimbursement fees, reasonably related to reasonable and just rates and charges for such services. Such rates and charges, upon annual review, shall be approved on or before February 1st of each year after adoption by this Ordinance, and such updated rates and charges shall be amended in Exhibit "A" for the next year comprised of February through the end of January of the next succeeding year for systematic annual updating and amendment, all based upon the requirements for establishment of just rates and charges under I.C. § 36-1-3, et seq., as amended.

SECTION FIVE: That the reimbursement fee policy and procedures established hereby shall conform to and comport with the rules, regulations, and requirements of applicable Indiana law, and rules and regulations of the Indiana State Board of Accounts. This policy and procedure shall be monitored and followed in the same manner and method as the procedures and policies of the Town Municipal Fire Department for ambulance and related emergency medical service charges and rates made by the Town Municipal Fire Department to benefitted individuals and/or entities. For purposes of conformance to applicable Indiana law, in the event of failure or refusal to pay an issued and charged reimbursement fee billing invoice for fire, safety and rescue and hazardous material and environment incident response services by the Town Municipal Fire Department, and upon the issuance of billing invoices which are unpaid, the Town shall be entitled, under applicable law, to recovery of legal fees and expenses, including attorney fees, plus interest on unpaid accounts as permitted by applicable statutory authority.

SECTION SIX: That all existing Town Code Sections and Ordinances, or parts thereof, in conflict with the provisions of this Establishment Ordinance, are hereby deemed null, void, and of no legal effect, and are specifically repealed.

SECTION SEVEN: If any section, clause, provision or portion of this Ordinance shall be held to be invalid or unconstitutional by any Court of competent jurisdiction, such decision shall not affect any other section, clause, provision or portion of this Ordinance.

SECTION EIGHT: That this Ordinance shall take effect, and be in full force and effect, from and after its passage and adoption by the Town Council of the Town of Cedar Lake, Lake County, Indiana, in conformance with applicable law, and publication in conformance with applicable law.

TOWN OF CEDAR LAKE, LAKE COUNTY, INDIANA ORDINANCE NO: 1355

AN ORDINANCE REPEALING TOWN CODE SECTION §35.01, ENTITLED <u>FIRE DEPARTMENT SERVICE CHARGE ESTABLISHED.</u>, AND TOWN CODE SECTION §35.02, ENTITLED <u>ITEMIZATION; LIMIT ON CHARGE.</u>, AND ALL MATTERS RELATED THERETO.

WHEREAS, the Town Council of the Town of Cedar Lake, Lake County, Indiana (hereinafter, the "TOWN"), has been reviewing provisions of the Town Code in support of its intent to establish a reimbursement fee to be charged and collected from responsible individuals and entities rendered Fire, Safety and Rescue, and Hazardous Material and Environmental Incident Response Services by the Town Municipal Fire Department; and

WHEREAS, the Town Council, in the course of its review and assessment, has been made aware that Town Code provisions exist pertaining to Fire Department Service Charges, and notably, by the provision of Town Ordinance No. 686, adopted by the then-Town Council June 25, 1996; and

WHEREAS, the Town Council, upon review and analysis, has determined that the provisions of Town Ordinance No. 686 establishing a Fire Department Service Charge were regulations for the then-existent and operational Cedar Lake Volunteer Fire Department; and

WHEREAS, the Town Council is aware that the Cedar Lake Volunteer Fire Department is no longer the operational entity of the Town for Fire, Safety and Rescue, and Hazardous Material and Environment Incident Response Services, but rather, that the Town Municipal Fire Department is said entity as a Department of Town Government; and

The GRANTEE shall have the right, at its expense, to enter along, over and upon the Temporary Easement for the public purposes permitted herein, at will, and to make such alterations and improvements therein as may be necessary or useful for such public purposes; further, the GRANTEE shall have the right of ingress and egress over adjoining premises and lands when necessary and without doing damage to the adjoining lands, and only for temporary periods, and shall not otherwise enter upon lands adjoining said Temporary Easement.

Hello Ms Murr,

I am hoping you can forward this email and photos to the Park's Dept and/or Town Council...

The Cedar Lake Softball league keeps holding tournaments for money (\$400 - \$600 per team?) with multiple teams on multiple days and with teams who come from out of the Cedar Lake area - with no direction for parking or clean up - so our neighborhood (and Little League) is inundated with their overflow of traffic. As you can see RV's and cars are parking in the grassy area of Hanover Park. The grassy area in Hanover Park was destroyed from Softball's overflow parking about a year and a half ago (Oct 2018) from one of their tournaments and Softball did not repair it, and parking on the grassy area continued in 2019 thru now. I hope that by bringing this to the attention of the Parks Dept or Town Council that some dialogue can happen to stop the damage and maybe get Softball to pay to fix the park?! Softball makes money by holding these tournaments, so they should pay to fix the park (not tax / town dollars). The deep tire ruts in the grass must be hard for the Parks Dept or Public Works to mow, and the ruts fill with rainwater and flood in that area now (it didn't before), which gives me concern about breeding mosquitoes, and it just plain looks bad.... Softball should not be able to run roughshod over the neighborhood and the Parks Dept and Town. Hanover Park looked so nice when it was finally cleaned up a few years ago, but Softball ruined it and takes no responsibility.

Shouldn't Softball pay the Town a permit fee for holding tournaments, which would hold them accountable for paying for traffic control, security, and property damage? Maybe the Town can consider a fee structure for these kinds of tournaments? I discussed that idea in 2019 with Councilwoman Colleen Schieben as well. We need some way to control these tournaments because no one is being held accountable.

I could not find an email address for the Parks Dept on the Town's website, so I am hoping you will forward the photos on to someone who can rectify the issue with Softball and make them repair the park - and stop the parking issues as well! Our neighborhood would sure appreciate it....



Dear Council Members:

This letter summarizes Christopher B. Burke Engineering, LLC (CBBEL) Town Engineer activities for reporting and action (as necessary) for the July 7, 2020 Town Council Meeting. This report covers activities for the period of May 15, 2020 through July 1, 2020.

1) Aquatic Ecosystem Restoration Cedar Lake Project, Section 206

No change from prior report. The project team has continued to respond to questions related to phasing of Town funding of the local share the project costs. The project team's effort is made in support of the Town Council's anticipated action on the design cost sharing agreement and other background decisions that the Council must address.

The project team meetings are temporarily on hold as the Council and Project team continue to evaluate the project approach and funding scenarios.

2) MS4 Coordination

No change from prior report. CBBEL has prepared a Fact Sheet for the local construction sector that summarizes the regulations and practices related to the management and handling of spoils and fill associated with land disturbance activities. The Fact Sheet was forwarded to Town staff today.

CBBEL is still waiting for consecutive days without precipitation to complete outfall

screening in accordance with the Town's NPDES Phase II Stormwater/MS4 Permit.

3) 133rd Avenue Phase 2 – Construction Services

CBBEL received comments from INDOT's material testing division last week. These comments should be addressed this week and we expect the testing certification letter to issued shortly thereafter. It is our understanding that this is the last issue prior to project close-out.

4) High Grove Subdivision Improvements

CBBEL completed a vegetation inspection throughout the site and specific to the Grimmer laydown areas last week. Vegetation has been established on a majority of the site, accept the site off Vermillion Drive that Grimmer used as their primary laydown yard. This site has large bare patches that don't comply with the minimum 70% coverage threshold required to close-out the Rule 5 permit. CBBEL will coordinate with Grimmer to re-seed this site or complete it outside of the contract and keep retainage.

5) 129th Avenue (Parrish Avenue to US-41) Improvements

Project design has been completed for this project. This project will be presented in the second Community Crossing Grant period of 2020. This period has been pushed to September. See below for further information.

6) NIRPC/State Legislature/INDOT/IDNR Updates

The NIRPC TPC Transportation Improvement Program Continuous Working Group has been working on a revised equitable application for a Fall 2020 Notice of Funding Availability (NOFA) call. We will update this when additional information is provided.

NIRPC issued notice of funds available through the U.S Economic Development Administration. These funds are related to the Public Works and Economic Adjustment Assistance Programs. These are revolving programs that don't have closing dates and are typically 50/50 matching between \$100,000 and \$3,000,000. The NIRPC summary sheet is attached to this letter. These programs have been partially funded when Congress appropriated \$1.5 billion via the Coronavirus Aid, Relief, and Economic Security Act (CARES Act).

The Indiana Office of Community and Rural Affairs (OCRA) has adjusted their upcoming grant cycles for the remainder of 2020 due to the pandemic outbreak. These grants would include CDBG and Planning and Blight Clearance grants among others.

Applications for the INDOT Railroad Grade Crossing Fund are due by July 31st. This is a 50/50 match program up to \$45,000. Only two crossing are allowed per funding term. We will most likely focus on 137th Avenue and 141st Avenue east of Parrish Avenue for this application.

7) Other Funding Opportunities

• Community Crossing Matching Grant, INDOT: CBBEL is awaiting final pavement testing results to complete the contract and specifications for the project. We expect these results next week and will shortly thereafter bid the project out. The project is required to be awarded no later than August 17th in accordance with CCMG quidelines.

The second Call for Projects was due to open on July 6th; however, due to the pandemic and potential state budgetary shortfalls, INDOT and the State Budget Agency have held the opening until further notice. The state budgets will be reevaluated in September when additional revenue forecasts are provided. This will NOT affect awarded funds under the first 2020 Call for Projects.

8) Highland Subdivision (High Grove, Phase 2)

No change from prior report. CBBEL provided a letter with lighting specifications and locations to NIPSCO on February 7th. DVG has prepared two drainage easement documents for the project. These easements were provided to the Town Administrator for review by the Town Attorney in November. We are waiting on NIPSCO procurement of easements.

9) Town Road Committee

CBBEL completed a field check on June 12th for Noble Oaks. Preliminary design is continuing for this subdivision. A field check will be made for the Shades Subdivision once the Noble Oaks design has been completed.

10) Redevelopment Commission

CBBEL is completing the following projects for the Redevelopment Commission:

• 133rd Avenue/King Drive Intersection Safety Improvements (DES No. 2000023): CBBEL forwarded information for an informal INDOT Stage 1 review on May 29th and received comments on June 17th. CBBEL also completed our field check meeting with INDOT on June 12th and no major concerns were noted with preliminary layouts. A soil boring was taken along the north ROW to support signal foundation design on June 22nd. This report should be completed soon. The Stage 2 submittal to INDOT is due on July 10th. It is our understanding that Hanover School Corporation has agreed

to a temporary easement to construct a sidewalk from 133rd Avenue to their main entrance. This signed easement agreement is required prior to receiving a ROW clear from INDOT.

- <u>Midway Gardens</u>: Three conceptual alternatives and cost estimates for the relocation of Lake Shore Drive were provided to the RDC on August 19th. It is our understanding this information is currently being evaluated. **No Change.**
- <u>Lake Shore Drive Retaining Wall:</u> The RDC has re-visited an evaluation completed by CBBEL in 2013 regarding the railroad tie retaining wall located along Lake Shore Drive adjacent to Bartlett-Wahlberg Park. CBBEL recommend a slope-stability analysis be completed prior to any repairs being considered. This wall is also most likely located on private property. **No Change.**

11) Plan Commission

CBBEL has been completing civil review and coordination activities for the following proposed developments:

- <u>Henn (former King Medical Building along Broadway):</u> This project was granted contingent Preliminary Plat approval on June 17th. The contingencies were payment of an alleyway improvement fee and satisfactorily addressing remaining engineering comments.
- <u>Birchwood Farms:</u> The project received Final Plat approval on June 17th for the first 36 lots of the subdivision.
- <u>Beacon East:</u> This project was deferred to the next public meeting pending remaining engineering comments and 141st Avenue ROW acquisition.
- Monastery Woods, South Letter of Credit Project: CBBEL was instructed on May 15th to obtain quotes for this project. Contract documents are under review by the Town Attorney
- <u>Development Standards Manual Update</u>: CBBEL has begun updates to the DSM. This work will continue throughout the summer. **No Change.**

12) Stormwater Management Board

<u>Oaks/Shades Wilson Ditch</u>: CBBEL has completed engineering plans and contract documents for this project. We are awaiting easement acquisition. CBBEL and Town staff met with the affected homeowners on February 5th. As a result of this meeting, CBBEL completed a site visit to evaluate upstream drainage issues related to Havenwood Subdivision. The larger upstream drainage issue may be addressed with a future project. **No Change.**

13437 Bluebird Lane, Robin's Nest: This is a rear yard drainage issue likely caused by a downstream property owner raising grades within a designated public utility and drainage easement. Town staff was directed to get a legal opinion on the removal of fences within

easements to gain access to the area. **Update: It is our understanding that Town staff is contacting the homeowner to discuss the requirements for a permanent easement to Bluebird Lane.** *No Change.*

<u>Woods of Cedar Creek</u>: CBBEL presented a proposed grading plan to Storm Board members for Lots 4 and 5. CBBEL is also preparing revised temporary easement documents for the new disturbance limits. **Update: This project will be quoted out in +/- 2 weeks with work to begin in late July or early August.**

13225 Colfax Street (Dust): CBBEL will present the preferred alternative to the Storm Board at the next meeting. This project will require easements on two parcels. Upon approval from the Storm Board, easement language will be prepared and submitted for legal review. Update: The homeowner did not agree to grant an easement or ROW dedication. The recommended alternative is not possible without legal right of entry. Therefore, this project will be moved to the street committee where possible roadway improvements will be evaluated to address the resident's concern.

<u>Stormwater Master Plan:</u> CBBEL is preparing a proposal for the completion of a Town-wide Stormwater Master Plan. This plan would include mapping of the Town's entire storm sewer network, identification of system problem areas, hydrologic/hydraulic modeling of specific areas, public participation meetings, and a final plan report detailing future projects and cost estimates. **This proposal will be presented to the Town later in the summer.**

13) Building Department

CBBEL completed as-built reviews for 23 lots in April 2020. CBBEL has also been completing on-going development reviews in the following subdivisions/projects: Summer Winds, Summer Winds Plaza, Birchwood Farms, Rose Garden Estates, Ledgestone, Centennial, Beacon Pointe, Lakeside, and Offshore Estates.

Zoning Map: CBBEL has completed the new zoning map for Town use. We are also finalizing a method to interactively view the zoning map on ESRI ArcReader software at Town Hall or even embedding a link on the Town's website for public viewing (if desirable). The ESRI ArcReader software is free and not licensed. This information has been conveyed to Town staff for a decision. **No Change.**
