1. Bid Award – Multiple Roadway Improvements

Mr. Eberly stated they have a copy of a recommendation letter from Christopher B. Burke Engineering. Milestone Contractors North had the lowest bid. Their bid came in a little under the engineer’s estimate at \$179,659.50. This is for roads on the west side.

A motion to approve the bid award to Milestone Contractors North in the amount of \$179,659.50 was made by Julie Rivera with second by Colleen Schieben. Mr. Niemeyer read the following list of streets into the record to be completed as part of this project:
