ORDINANCES

1. Ordinance No. 1443 – An Amendatory Ordinance for At-Large Council Seats Council Member Rivera read Ordinance No. 1443 by title only. Mr. Austgen explained the ordinance presented is provided to give clarification to the method and procedures to be used for Primary and General elections for the two (2) at-large Town Council seats. Ordinance No. 1423 is a good ordinance. The amended ordinance needs to include the protocols for which the two (2) at-large seats will be conducted and how a Council member will be selected. Mr. Austgen stated there are a number of places where the ratification and procedures are identified. Specifically, page 12, section two, identifies the procedure for both Primary and General Elections. Mr. Salatas added that the Lake County Board of Elections needed clarity for how they are to administer the election. A brief discussion continued.
