Information to Know

Notice of Abatement

§ 93.25 (C) Notice to abate. Upon receipt of a complaint that weeds, noxious growth, rank vegetation, or other environmental public nuisance exists in violation of this subchapter, the inspector shall make an inspection and upon confirmation of the same, shall cause written notice to be issued to the property owner by first class mail or an equivalent service permitted under IC 1-1-7-1, to:

- (1) The owner of record of real property with a single owner; or
- (2) At least one of the owners of real property with multiple owners; at the last address of the owner for the property as indicated in the records of the Auditor's Office of Lake County on the date of the notice.

(D) Contents of notice. The notice to abate shall contain the following information:

- (1) The address of the real property;
- (2) The date of the notice;
- (3) The address and the telephone number of the Planning and Building Department; and
- (4) A statement that the designated violation shall be removed from the property within five calendar days after the mailing of the notice, or the owner must file an appeal. In the event that the inspector finds a violation pursuant to such definition of "TRAFFIC HAZARD," the inspector shall have the authority to waive the five day grace period and abate the problem as soon as possible.

(E) Continuous abatement. If an initial notice of the violation of an ordinance adopted under this section was provided by certified mail, first class mail, or equivalent service under division (C) above, a continuous abatement notice may be posted at the property at the time of abatement instead of by certified mail, first class mail, or equivalent service as required under division (D) above. A continuous abatement notice serves as notice to the real property owner that each subsequent violation during the same year for which the initial notice of the violation was provided may be abated by the town or its contractors.

Branch Collection Guidelines

The Cedar Lake Public Works Department collects tree branches starting on the **first business day** of each month from April through October 1st, weather permitting. Branch pickups will be completed **within the first 5 to 10 business days** of the month. Please have branches ready and out by the street, not in the street, before the first business day of each month to ensure your branches get picked up. Public Works has a regular route starting at one end of town and continuing to the other end of town until the entire Town is picked up/serviced.

- For safety reasons, branches must be at least 48 inches in length. Anything shorter is considered yard waste and should be cut up and disposed of in your regular, weekly trash collection
- The Town's chipping equipment can safely process branches up to 8 inches in diameter.
- Grass, bricks, stones, metal objects, stumps or branches larger than 8 inches in diameter should not be placed in branch piles. These materials can damage the chipping equipment, which could result in injury to a Town employee. Such branch piles will be bypassed and will receive a door hanger if any improper items are noticed.
- Please do not mix leaves, yard waste, and branches together.
- Please do not bundle branches or place them in containers or bags.
- Do not place branches by mailboxes, waterways, drainage, or utility poles.

Calling when yard work is completed is not necessary.

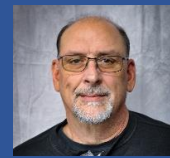

Projects

Shades Subdivision, Phase 1B:

Roadway and stormwater improvements construction begins this spring for Edison Street, Mary's Lane, Rocklin Street, and Sherman Street north of 141st Avenue. The roads will be open for local traffic only with intermittent access during construction hours, 7am – 5pm. All residents should proceed on 141st Avenue with caution. The remaining roadway paving on 141st Avenue from Hobart Street to the east Town limit will occur later this summer.

2024 CCMG Crack Sealing Project:

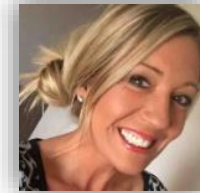
This project includes asphalt roadway crack sealing over 7 miles of major roadways throughout the town. The roads include W. 133rd Avenue from West Town Corporate Boundary to US-41 & W. 133rd Avenue from Morse Street to Colfax Street, Lake Shore Drive, Morse Street, 145th Avenue, 147th Avenue, Lauerman Street, and 137th Avenue. This project includes new pavement markings on W. 133rd Avenue from the West Town Corporate Boundary to US-41 & W. 133rd Avenue from Morse Street to Colfax Street. Traffic will be flagged one way, but remain open from 7am – 5pm.
